The event was part of MI's PROSAFE Project supported by the New Zealand Aid Programme.

Meetings with Corn Farmers Held

Thirty-two contract farmers from northern Myawaddy, and seven farmer leaders from the south attended farmer meetings last November 8 together with members of Bio Supreme Company, the Myanmar Corn Association, and EWEC Myanmar Field Office. The group discussed detailed plans for collecting maize from the contract farmers, storage methods and selling practices of maize, and the advantages of collective marketing by farmer groups, as well as ways to cover losses from the flooding incident.



EWEC Myanmar Continues Efforts to Strengthen Farmer Groups

The EWEC Myanmar Field Office continues efforts to encourage farmers to form farmer groups with recent training in Chaung Son and Thae Pon villages, Myawaddy last November 5 and 6, 2018. Some 47 farmers from Chaung Son village and 31 from Thae Pon village attended the training that was organized in collaboration with the Awba Input Company. The formation of farmer groups is strongly encouraged in the tripartite model to allow farmers to increase their income by selling directly to local traders and gaining access to loans at lower interest rates for the purchase of farming inputs.

MI Co-organizes Forum on Korea's Role in Mekong Cooperation

MI jointly hosted with the Embassy of the Republic of Korea (ROK) the recently-concluded Forum on Korea's Role in Mekong Cooperation last November 29 in Bangkok, Thailand. Attended by over 60 delegates from government, international, non-governmental institutions and the academe, the forum highlighted the cooperation efforts of ROK along its New Southern Policy. MI Executive Director Dr. Watcharas Leelawath was panel discussion moderator, while Mr. Madhurjya Kumar Dutta, Director of the Trade and Investment Facilitation Department spoke about MI's role as fund manager of the Mekong-ROK Cooperation Fund.
