MI Co-organizes GAP Training for Kandal Vegetable Farmers

MI, together with the Provincial Department of Agriculture, Forestry and Fisheries (PDAFF), Kandal Province, Cambodia conducted the localized training on *Good Agricultural Practices* (GAP) on July 4-5, 2017.

Twenty-four vegetable producers and extension workers from Sa-Ang District participated in the training course, which aimed to enhance the participants' knowledge and technical capacity on GAP principles, as well as introduce to them appropriate agrichemical and pest management practices to ensure the quality and safety of their fresh produce. The training was spearheaded by an MI alumnus who attended the Regional Training Program on Assuring Food Safety through

Pest and Agrichemical Management held last May 2017, together with an expert from the Department of Plant Protection, Sanitary and Phyto sanitary under the Ministry of Agriculture, Forestry and Fisheries in Cambodia. **Read more** <u>here</u>.

Regional Training Program on Food Safety Risk Analysis

MI, with support from the New Zealand Aid Programme (NZAP), conducted the nine-day *Regional Training Program on Mainstreaming Food Safety Risk Analysis* from July 10 until 21, 2017, at the MI Residential Training Center. The program was the fifth in a series of food safety training programs organized under the MI-Food Safety Project (MI-FSP).

This training program aimed to enhance the knowledge and technical capacity of 25 participants from relevant government agencies, academic and research institutions, and consumer associations in Cambodia, Lao PDR. Myanmar, and

Vietnam (CLMV) in assessing, managing, and communicating food safety risks. In addition, the training introduced the basic concepts in preliminary risk management activities, identification and selection of risk management options, implementation and control measures, and monitoring and review. **Read more <u>here</u>**.

Workshop on GMS Power Equipment Operation

MI continuously emphasizes on furthering energy cooperation in the region. Consequently, in partnership with China Power Southern Grid, MI launched the two-day workshop on *GMS Power Equipment Operation and Maintenance and Safety Management Standard Code* on July 20-21, 2017, at the MI Residential Training Center. Thirty-one CLMV government officials joined the workshop, which aimed to enhance their understanding of the field. The initiative also explored the field's standards and code for GMS power interconnection.

Regional Training Workshop on Promoting Consumer Awareness on Food Safety

Following the series of workshops that MI has been conducting in partnership with NZAP, the weeklong *Regional Training Program on Raising Public Awareness for Safe Food Consumption* was conducted at the MI Residential Training Center. The sixth course under the MI-FSP ran from July 24–28, 2017.

Twenty-seven representatives from government agencies, academic institutes, and the private sector in Cambodia, Lao PDR, Myanmar and Vietnam attended the training, which

aimed to introduce effective strategies in engaging consumers to be aware of the importance of food safety and, in turn, push for safer fresh produce. The course also intended to strengthen the capacity of the participants to develop and implement practical strategies in developing consumer messages and communication strategies on food safety hazards and risks. **Read more** <u>here</u>.

EWEC (SDC) PROJECT ACTIVITIES

Deputy Minister of Ministry of Agriculture and Forestry Commends Project's Outputs

On July 15, 2017, H.E. Phuangpralisack Pravongviengkham, Deputy Minister of the Ministry of Agriculture and Forestry and a delegate from the ministry and provincial level visited the rice production and manufacturing sites. The visit took place after the cooperative members visited Xuanye (Lao PDR) Sole Co., Ltd. in June 2017. *(continued on page 3)*

The objectives were to see the operation of the Cooperative, to note the improvements of rice production and manufacturing through GAP and GMP, and to explore the potentials of exporting rice. The president of the cooperative presented the establishment and business operation, and explained the plans of the cooperative. The Deputy Minister recognized and commended the plan and activities, citing that these will be on the same path as the plans of the Agriculture Development Strategy to Central Government. Moreover, he stressed on providing the benefit allocation and enhancing social welfare among shareholders and beneficiaries. Afterwards, he visited a GAP rice paddy field as well as rice mills, which are implementing GMP application.

It was the first significant event that showed satisfactory improvements as attested by an eminent government official. It also demonstrated that projects are running on track and the advices will be taken into account for significant improvements in the future. In addition, this served as an important step in preparation for the visit of a Chinese company for rice exporting.

EWEC SLVs Promote Cooperation Between Plant Quarantine Stations

As a follow-up activity to improve cross-border trade between Thailand and Myanmar, the project organized Structured Learning Visits (SLVs) to Mae Sot Plant Quarantine Station along with Myawaddy Plant Quarantine on July 25, 2017.

The primary objective of the SLVs were to build partnerships between organizations; to exchange the application procedure in inspecting plant and plant products; to observe the mechanism of inspection; and to further cooperation initiatives and potentials between the two organizations for trading agri-products crossing the borders. Four participants from the Myawaddy Plant Quarantine Section, led by supervisor U Hla Wai, joined the SLV to Mae Sot The Chief of Mae Sot Plant Quarantine welcomed the SLV group and provided information

regarding the plant quarantine system in Thailand, mechanism of inspection on export/import of agri-products, and rules and regulations.

The visit group discussed the restriction and permission codes of each country and clarified the necessary documents for the export/import of agri-products. They also explored the possibility of making the process the process simpler and



applicable between the two countries, and shared the governments' policies regarding plant quarantine.

The study tour group visited the border check point No. 13 located beside a river to observe mechanism of inspection on agri-products imported from Myanmar. The group also met a Thai agri-product trader, who shared the challenges of importing agri-products from Myanmar particularly the long delay of issuing documents from Thailand.

The recent process of issuing SPS certificate in Yangon, Myanmar facilitates an easier system for traders to collect their documents. This was the very first meeting between the Plant Quarantine Sections of the two border provinces, particularly Myawaddy - Mae Sot, which is supported by the

Myanmar Field Office of EWEC. Representatives discussed future cooperation initiatives such as sharing new quarantine policies between the two countries, official visits of Mae Sot Plant Quarantine in Myawaddy, and information and technology sharing for the new checking point when bridge 2 will be fully operational.

Coffee Nursery Matching Market Demand

On July 26, 2017, representatives of Quang Tri Department of Agriculture and Rural Development (DARD) and its line agencies, local authority and project team paid a joint visit to the coffee nursery at Huong Do village of Huong Phung commune, Quang Tri Province. This was part of the commitment of DARD to carry out technical monitoring and support on a regular basis after the project ended its support to the model.

During the visit, DARD staff worked closely with the nursery owner to conduct technical analysis and all the participants discussed about marketing. The young trees were assessed as having good health and rapid growth. On an area of 250 square meters, the owner has successfully nursed

more than 15,000 young trees of new variety (THA1), occupying over 100% of the expected targets. Out of this, more than half were bought mostly by Huong Do quality coffee producing farmer group in which the owner is a member. The trees were sold to Huong Do farmer group for a lower rate, as committed by the possessor, in order to commend great efforts of his group members in participating in the successful linkage models in the past years under the support of the project.

The setting up of this nursery ushers in a significant opportunity for smallholder coffee farmers in the context of the growing need for replantation. Most importantly, the Quang Tri Provincial People's Committee issued the Decision No.837/QD-UBND on April 24, 2017 to approve the *"Replantation of and sustainable development of coffee trees in Quang Tri province during the period of 2017 to 2020"* proposal submitted by DARD.

The objectives of the proposal are to improve the quality and productivity of coffee trees, thus improving the competitiveness of the coffee sector in the province. According to the proposal, around 41% of the total coffee plantation area in the province needs replantation. In addition, the local authorities were committed in providing a 50% financial subsidy to acquire seedlings for farmers participating in this replantation plan.

MI warmly welcomed the NECTEC Delegates, headed by Dr. Kanokvate Tungpimolrut - NECTEC Deputy Executive Director, on July 5, 2017, at the MI Headquarters in Khon Kaen, Thailand.

Dr. Watcharas Leelawath, MI Executive Director, together with the MI-Innovation and Technological Connectivity (ITC) Department, headed by Mr. Sudam Pawar, presented MI's initiatives and actions on energy cooperation and adoption of technology to improve lives. The visit aimed to promote engagement from both parties in advocating new technologies that support various stakeholders, particularly SMEs in the region.
