#### **Training Needs Assessment for Food Safety Project**



With the support of the New Zealand Aid Program (NZAP), MI conducted a training needs assessment for the Food Safety Project in four countries – Cambodia, Lao PDR, Myanmar and Vietnam from August 9 to 25. The activity was led by two New

Zealand Food Safety experts.

Six training topics were identified to address needs in the four countries: (1) Agri-chemical management – tools to create change; (2) Postharvest management from food safety perspective; (3) Tools to achieve food safety GMP, GHP; (4) Food Safety in the market place, domestic distribution and export; (5) Consumer and food safety understanding; and (6) Tools to effect food safety: Verification, Certification and Traceability.

#### **Good Agricultural Practices (GAP)**

From August 15 to 26, MI organized a training program on Good Agricultural Practices (GAP) sponsored by Thailand International



Cooperation Agency (TICA). The course aimed to enhance Laos government officials' capacity in promoting GAP to ensure the free movement of safe, healthy, and quality food in the region. The participants had the opportunity to learn from Thailand's practices and experiences related to GAP application in GAP certified fields in Khon Kaen and Nakhon Ratchasima.

# **EWEC (SDC) PROJECT ACTIVITIES**

#### **5th Session of Training Series on GMP Standardization**



The 5th session of the Good Manufacturing Practice (GMP) training series was conducted at the Department of Industrial Commerce in Khammouane, Lao PDR on August 9, 2016. As part of the GMP standardization in the rice sector which has been implemented since February 2016, the workshop was attended by 30 participants from different sectors such as rice mills, hotels, restaurants and government. The objectives of the workshop were to report on the progress of GMP standardization, disseminate information, and

provide updates on the certification processes, as well as to distribute GMP application signboards to pilot rice mills.

### 2nd Session of Training on IPM: Study on Biodiversity in the Paddy Fields, Snails and Fruit Composting



The 2nd session of the training on Integrated Pest Management (IPM) was conducted from August 10 to 12, 2016 in three districts: Ban Nongping of Nhommlath District, Ban Dongtai of Thakhek District, and Ban PhakEtou of

Nongbok District. Members of the four pilot GAP groups attended. The training provided farmers with information about the biodiversity in the paddy fields to build up their awareness and knowledge of predators and parricides, as well as about how to make compost by using snails, vegetables and fruits.

## **Mid-Term Assessment for Season** 2015

The mid-term assessment for the 2015 season was conducted from August



6 to 16, 2016, by external consultants in the five townships in the Kayin State where the project is being implemented.

#### Learning Moments among Farmer Groups



On August 16, 2016, a meeting at the Khe Sanh Township, Huong Hoa District of Quang Tri in Vietnam was joined by 63 participants from the Khe Sanh Coffee Association (KCA),

farmer groups, enterprises, VNFO, and representatives of the EMEE Project of World Vision. The meeting offered opportunities to share information and learn from one another about the operation and management of the farmer groups, as well as how to access the linkage models in an effective manner. Both the farmer groups and enterprises helped develop an action plan which now serves as the basis for linkage dialogues between both sides in the upcoming crop-year.

# **Dialogue between Farmers and Experts**

A dialogue between farmers and experts on the theme "Khe Sanh Coffee - A Journey of Branding Development", was held on August 24, 2016 at the Tan Hop Commune, Huong



Hoa District of Quang Tri, Vietnam. The dialogue aimed to create a forum for coffee farmers to communicate directly with experts in different fields: policymaking, credit provision, agricultural extension, and market information, among others. The farmers benefited from the experts' answers while the latter gained a better understanding of the farmers' needs. Both sides now have a stronger commitment to achieve high quality production and sustainable development in the sector, thus contributing to the development of Khe Sanh Coffee.
