Mekong Institute at the Vietnam – Asia Silk Culture Festival 2016



Hoi An, Vietnam (March 2016) – the Asia Silk Alliance (ASA) and the International Silk Union (ISU) organized the Vietnam – Asia Silk Culture Festival 2016 last March 28-29, 2016 through Hoi An Silk Village Joint Stock Company. The festival gathered over 70 representatives from the local traditional silk villages, fashion designers, silk traders, silk exporters, government officials, researchers, and other members from China, Japan, India, Myanmar, Thailand, France, Italy, and Spain. The event aimed to create an official

platform connecting and promoting activities of ASA and ISU members for business development and cooperation between silk centers in Asia and the world. More>>

■ EWEC (SDC) PROJECT ACTIVITIES

Dissemination Meeting on the Benefit of Certified Rice Seed Usage



The dissemination meeting on the benefit of certified rice seeds usage was conducted in four districts of Khammouane province, Lao PDR, on March 17-22, 2016. 21 villages were involved and a total of 353 people participated. The objective of the meeting was to disseminate the information and knowledge of using certified seeds to farmers. This year, more topics were added, such as Integrated Pests Control (IPM), cultivation calendar, etc. In addition to the officers from PAFO and DAFO, Rice seed producers from each group also shared knowledge.

2nd Series Training on Good Manufacturing Practice (GMP) to Rice Mills

The 2nd series training on GMP was conducted in Khammouane, Lao PDR, on March 22-29, 2016, attended by 24 selected rice millers including their staff, as well as seven representatives from DoSMEP and DIC. The objective of the training was to get updates from the 1st training implemented by rice mills as monitored by government staff. Another aim was to provide knowledge of different topics such as how to draw factories layout, machine layout, list of all processing equipment, etc. At the end of the training, all participants planned ahead for future trainings such as processing analysis and creating relevant forms.



Post-Conflict Approaches towards Local Economic Development in Kayin State



The Synthesis and Evaluation Workshop on "Post-Conflict Approaches towards Local Economic Development (LED) in Kayin State, Myanmar" was organized at Gabbana Hotel, Hpa-an, Kayin State on March 5, 2016. The workshop aimed to recap the lessons acquired from the first phase of training, share the experiences of participants in implementing action plans, assess the feasibility and application of LED knowledge at their workplaces, and learn the recommendation for future LED training needs. The workshop was attended by 11 out of 15 participants who

previously participated in the first training. It was found that most of the participants eagerly disseminated the knowledge on LED through departmental meetings, trainings, and departmental LED promotion activities.

EWEC (SDC) PROJECT ACTIVITIES

Buyer-seller Meeting at Mawlamyine

EWEC organized a buyer-seller meeting on March 9, 2016 for new maize growers, to start building relationships with existing buyers in Mawlamyine. The farmers from the new extended areas - Kyar Inn Seik Gyi, Paing Kyone, and Hpa-an also joined. They discussed about the buying mechanisms of maize and other crops and visited the warehouses. There were 10 farmers and four government staffs from DOA and DOTP.



Training on Project Proposal Writing



A training of project proposal writing was conducted on March 14-19, 2016 for 15 members of the Khe Sanh Coffee Association (KCA), GOs and

enterprises including Quang Tri Center of Agricultural Extension, DARD, Division of Economy & Infrastructure of Huong Hoa, Department of Science and Technology, and Binh Dien Fertilizer Company. They all gained an overall understanding of project management and the steps of proposal writing to be able to develop and submit high quality project proposals.

Workshop on Introduction and Replication of Successful Models

March 25, 2016, Fiftyeight representatives from different levels, including INGOs, staff of local authority



agencies, farmers, enterprises and representatives from the Agribank of Huong Hoa district were introduced to successful linkage models demonstrated by the RLED-EWEC to encourage potential roll-out in other communes in the upland district of Huong Hoa.

areas where MI can work in partnership with ASEC to promote equitable economic development in ASEAN, especially the new ASEAN member countries.


ASEAN -New Zealand Regulatory Workshop and the ASEAN-OECD Good Regulatory Practice Network (GRPN)


