Official Approval of the Revolving Fund

The KOICA-sponsored Happiness Program (HP) delivered a notification of official approval of the "Fertilizer Revolving Fund" project at a meeting held on November 10, 2016 in Dong Hacity, Vietnam.



By creating better access to finance for 124 farmers, the revolving fund aims to help farmer groups generate income through high quality, cost-effective coffee production in Huong Hoa district.

The total revolving fund budget is around \$65,000 USD, out of which \$50,000 USD is funded by HP, with the remainder co-funded by MI and additional contributions from the Khe Sanh Coffee Association (KCA). The revolving fund will be implemented by the KCA over three years in Huong Hoa district of Quang Tri, Vietnam.

■ EWEC (SDC) PROJECT ACTIVITIES

Kick-off meeting on the Investment Promotion Portal

The RLED-EWEC Project of MI and the Office of Quang Tri People's Committee (PPC) gathered on November 15, 2016 to deploy the initiative on "Setting up Investment Promotion Portal of Quang Tri province" after the Cooperation Agreement was signed by the two parties.



The initiative aims to contribute to Quang Tri's socio-economic development in the

context of strong international integration by enhancing investment promotion and developing the capabilities of the PPC Office and relevant departments.

In particular, the project will help develop a unified investment promotion database for Quang Tri during 2016 - 2025, with a vision to 2030. The database will serve as an investment promotion portal in multiple languages. Through the websites of Vietnam's embassies, it will link Vietnam Representative Offices to foreign countries and territories that Quang Tri has prioritized as targets for investment promotion.

Linking Feed Factory with Traders and Brokers

A linkage activity was conducted to connect maize traders and brokers from Mawlamyine and Myawaddy with the Sunjin Feed Factory in the Bago Region of Myanmar from November 16 to 17, 2016.

The purchase supervisor of the feed factory, which is interested in expanding its raw material sources, explained the requirement standards and purchasing practices and planned to visit Myawaddy to check the volume and quality of the crop in December.
