Executive Summary

Mekong Institute (MI), with the support from the Lancang – Mekong Cooperation Special Fund, organized a two-day Synthesis and Evaluation (S&E) Workshop on 'Management of Special Economic Zones in Lancang – Mekong Countries' on February 12 - 13, 2019 at MI's residential training center in Khon Kaen, Thailand. The S&E Workshop aimed to review learning from a modular training program on the subject "Management of Special Economic Zones in Lancang-Mekong Countries" held on September 24-28, 2018 in Khon Kaen, results of implementation of action plans for three months following the one-week training including best practices and outcomes, and obtain feedback on the modular training cycle.

13 participants from Lao PDR, Myanmar, Thailand and Vietnam attended the S&E workshop, representing public and private sectors including ministries and departments of commerce, finance, planning and investment, foreign affairs, special economic zone (SEZ) policy development and monitoring agencies, and SEZ developers. The workshop participants presented and discussed issues such as importance of cross border economic cooperation zones, management of SEZs and cross border economic zones (CBEZs) focusing on global value chains and new disruptive technology, and policy framework for improving SEZs.

The S&E participants informed that over 300 stakeholders benefitted from AP implementation in Lao PDR, Myanmar, Thailand and Vietnam from September 2018 to February 2019. The participants acquired new knowledge and skills through national workshops, seminars and knowledge sharing carried out by the training participants during this period.

In addition, the following points were discussed in the S&E workshop:

- i. Sources of key information on SEZs in the Lancang-Mekong countries for developing an online SEZ portal such as legislations, maps, trade and investment data, incentives provision for investors, investment cost, infrastructure, labor resource, public services, one-stop services and other services.
- ii. Assessment of the modular training cycle against the REESI principle (Relevance, Effectiveness, Efficiency, Sustainability and Institutional Development) including the impact of the training program.

Results of participants' evaluation of the S&E workshop suggested that the modular training program met expectations and contributed to enhancement of knowledge of participants and beneficiaries on management of SEZs in the Lancang – Mekong Countries. Participants also suggested some areas for further improvement by MI, including better identification of target groups for national workshops, time and budget for group AP implementations, and inclusion of study visits to successful SEZs and CBEZs in the modular training program.

Synthesis and Evaluation (S&E) Workshop

Management of Special Economic Zones in Lancang – Mekong Countries

1. Workshop Summary / Overview

1.1. Background

Mekong Institute (MI) in coordination with the Ministry of Commerce, Royal Government of Thailand and with the support of Lancang-Mekong Cooperation Special Fund, conducted a Modular Training Program on "Management of Special Economic Zones in Lancang-Mekong Countries" on September 24 - 28, 2018 at its residential training center, Khon Kaen, Thailand, which was followed by action plan implementation for three months in the individual countries.

The training aimed to

- i. Improve knowledge base of participants by sharing status on progress on cross border economic zones (CBEZs)
- ii. Build capacities of the special economic zone (SEZ) officials and private sector on various issues related to management of SEZs
- Share best practices on SEZs / CBEZs and provide examples from Lancang-Mekong (LM) countries, and
- iv. Promote learning and exchange among stakeholders.

The curriculum of the training program included five interrelated modules: 1) Addressing domestic development challenges 2) Leveraging global and cross-border "drivers of change" 3) What makes an SEZ "special" 4) From SEZ to CBEZ and 5) SEZ (and CBEZ) development framework.

As part of the training program, the participants developed country action plans (AP) for transferring knowledge and experiences acquired through the training program to relevant beneficiaries and stakeholders in the LM countries namely China, Cambodia, Lao PDR, Myanmar, Thailand, and Vietnam. As part of the AP implementation, national workshops / trainings were required to be conducted in individual countries of the LM region.

To discuss learning of the AP implementation and obtain feedback on the modular training cycle, a two-day Synthesis and Evaluation Workshop (S&E) was organized on February 12-13, 2019 at Mekong Institute, Khon Kaen, Thailand. The S&E workshop aimed at (i) providing a platform for the participants to present results of their AP implementation; (ii) sharing best practices from their AP implementation experience; and (iii) reflecting on their feedback on the training for making improvement in training contents.

1.2. Objectives

The specific objectives of the S&E Workshop were to:

- a) Recollect the knowledge gained from the modular training program on Management of Special Economic Zones in Lancang-Mekong Countries;
- b) Share experiences of implementing APs and obtain feedback from co-participants;
- c) Provide an opportunity to learn, share best practices and utilize the learning results;
- d) Evaluate the training approach and provide recommendations for future improvement in terms of contents, structure, and schedule.

1.3. Expected Outputs

Expected outputs of the workshop included enriched insights of the participants on the impact of the training program and AP implementation. This was also a chance for MI to receive recommendations from the participants for improvement, modification and/or further development of MI's training programs.

2. Workshop Method

The S&E workshop had three parts. The first part included the presentations by the participants on their APs implementation. The participants presented the results of their AP implementation with photos, power point presentations and discussions in line with the topics and methods applied. The workshop also served as a platform for participants to exchange their experiences and lessons learned from their APs implementation.

In the second part, the participants discussed the issues on key related information on SEZs in the Lancang-Mekong countries for developing an online SEZ portal such as legislations, maps, trade and investment data, incentives provision for investors, investment cost, infrastructure, labor resource, public services, one-stop services and other services, and each country group presented the results of their discussions.

The third part consisted of group work by country on the evaluation of modular training program by using the principles of Relevance, Efficiency, Effectiveness, Sustainability, and Institutional Development and Other Impacts (REESI) to assess its impact. Each group also presented the results of their group work.

3. Participant Information

13 participants from Lao PDR, Myanmar, Thailand and Vietnam, representing the public and private sectors, including ministries and departments of commerce, finance, planning and investment and, foreign affairs, SEZ policy development and monitoring agencies, and SEZ developers, attended the S&E workshop.

There were four (4) participants from Lao PDR, four (4) from Myanmar, and two (2) from Vietnam and three (3) from Thailand. Among them, six (6) were female. In terms of sector, eight (8) participants or 62% were from the public sector and five (5) participants or 38% were from the private sector.






Figure 1. Participants Ratio

4. Workshop Outputs

During the S&E Workshop, participants reflected and shared the outcomes, experiences, best practices, lessons learned and the suggestions, and learned from co-participants on their APs implementation. Participants discussed and provided key related information on SEZs in the Lancang-Mekong countries for developing an online SEZ portal. Participants also conducted an evaluation of the modular training program by using the principles of REESI to assess the impact of the training program and to provide recommendations for future improvement in terms of contents, structure and schedule. By doing these, participants enhanced their insights on the impact of the training program.

5. Workshop Contents

5.1. Welcome Remarks

Dr. Watcharas Leelawath, Executive Director, MI



Dr. Watcharas Leelawath welcomed all the participants in MI for the S&E Workshop. Dr. Leelawath underlined the importance of SEZs in Lancang-Mekong regions for economic development, attracting foreign direct investment, generating benefit to local stakeholders and investors and, achieving inclusive and equitable growth.

Dr Leelawath said collaboration and cooperation mechanisms between SEZs in the

Lancang-Mekong region should be promoted for further labor skills improvement and economic development in the region.

5.2. Overview of the S&E Workshop



Mr. Sa-nga Sattanun, Program Manager, Trade and Investment Facilitation (TIF) Department, MI

Mr. Sa-nga Sattanun explained the modular training approach MI adopted for the training program. This includes (i) **Learn to Do:** Regional Modular Training on Management of Special Economic Zones in Lancang-Mekong Countries (September 24 - 28, 2018); (ii) **Do to**

Learn: APs implementation (September 2018 - February 2019); and (iii) **Share to Learn:** S&E Workshop (February 12 - 13, 2019). Mr. Sattanun also explained the objectives, expected outputs, structure and contents of the training program and the S&E Workshop.

5.3. Presentation of AP Implementation Results

The participants presented the results of their APs implementation with photos, power point presentations and discussions in line with the topics and methods applied.

5.3.1. Myanmar, Yangon

Introduction



On November 29-30 2018, Myanmar's Ministry of Commerce, Ministry of Natural Resource and Environmental Conservation, Thilawa Special Economic Zone and Ocean Crown Co., Ltd jointly organized a two-day national workshop on "Management Practices of Special Economic Zone" at Trade Training Institute, Yangon, Myanmar. The workshop was held as a part of the AP of the Regional Modular Training on Management of Special

Economic Zone in Lancang – Mekong Countries (September 24 - 28, 2018).

Objectives

The national workshop aimed to

- Improve/update knowledge base of participants by sharing status on progress on CBEZ globally and in the Lancang Mekong countries including Myanmar;
- To share best practices on SEZs/CBEZs and provide examples from the Lancang Mekong Countries on development of SEZs/CBEZs;
- To form a knowledge base to complement the existing knowledge on SEZs/CBEZs in Myanmar.

Participants

37 participants from concerned government agencies and private companies attended the national workshop, including representatives from chambers of commerce and industries, SEZ management committees, and freight forwarders.

The national workshop was comprised of the following sessions:



 Session 1: "What makes an SEZ special?", delivered by Dr. Shwe Hein, Secretary of Thilawa SEZ Management Committee;

- Session 2: "From SEZ to CBEZ", delivered by Ms. Zin Mar Htun, Director, Ministry of Natural Resources and Environmental Conservation;
- Session 3: "CBEZ Development Framework", delivered by Dr. Khaing PhyoAung, Director, Ocean Crown Co. Ltd;
- Session 4: "Special Economic Zones (SEZs) and Cross Border Economic Zones (CBEZs)", delivered by Dr. Htein Lynn, Director, Ministry of Commerce.

Key Outcomes

- Participants rated that the workshop content and topics have met their expectations and related to their work;
- Participants reported that their knowledge and skills on SEZs and CBEZs have significantly increased.
- An article on the workshop event was released in a local newspaper.

အဆိုပါဆွေးနွေးပွဲသည် စက်တင်ဘာ ၂၄ ရက်မှ ၂၈ ရက်အထိ ထိုင်းနိုင်ငံ၊ Khon Kaen မြို့တွင် ကျင်းပခဲ့သော လန်ချန်း-မဲခေါင် နိုင်ငံများတွင်ကျင့်သုံးနေပြီး အထူးစီးပွားရေးဇုန်များနဲ့ပတ်သက်တဲ့ စီမံခန့်ခွဲမှုဆိုင်ရာ အလုပ်ရုံဆွေးနွေးပွဲ၏ Action Plan အရ ပြုလုပ်သော ဆင့်ပွားဆွေးနွေးပွဲဖြစ်ကာ နိုင်ငံဖြတ်ကျော် စီးပွား ရေးဇုန်များ၏ တိုးတက်မှုအခြေအနေကို သိရှိနားလည်စေရန်၊ ပါဝင်ဆောင်ရွက်မည့် ပုဂ္ဂိုလ်များ၏ စွမ်းဆောင်ရည်မြှင့်တင်နိုင်စေရန်၊ အထူးစီးပွားရေးဇုန်များ ဖွံ့ဖြိုးတိုး တက်ရေးဆောင်ရွက်ရာတွင် အထောက်အကူဖြစ်စေရန် ရည်ရွယ်ကျင်းပြစင်းဖြစ် ကြောင်း သတင်းရရှိပါသည်။

Conclusions

- The Myanmar team has been utilizing the lessons learnt from MI's modular training by implementing these in their own work place with action plans by developing systems and internal knowledge sharing.
- The national workshop participants were satisfied with the expertise of resource persons and training methodologies employed during the workshop.

• The outcome of the workshop was successful as per the evaluation made prior to the workshop in comparison with the evaluation made at the end of the session.

Recommendations and Way Forward

- Need more training and information exchange for SEZ stakeholders in Myanmar;
- MI should continue to support for training and help logistics businesses to move forward in the Lancang-Mekong Countries;
- Need more practical examples and experiences on how to apply the knowledge and to develop SEZs in Myanmar;
- Continue to provide new update on SEZs/CBEZ in the Lancang-Mekong countries;
- Suggested MI to invite more participants from relevant ministries and companies;
- Need more budget to organize this kind of training and invite more companies to attend such a training.

5.3.2. Thailand – Mukdahan Province

Introduction



On January 25 2019, Mukdahan Provincial Office, Office of Labor Skill Development, and Mukdahan Federation of Thai Industry jointly organized a seminar on 'Preparing and Training for Super Worker for Economic Growth on SEZ in the GMS' in Mukdahan, Thailand. The workshop was held as a part of the AP of the Regional Modular Training on

Management of Special Economic Zone in LM Countries.

Objectives

The seminar aimed to

- To build cooperation between the public and the private sector in developing the labor force for the economy expansion in the GMS region;
- To raise management quality of labor-related personnel;
- To solve the problem of shortage of qualified workers in the region;
- To establish labor-related personnel guidelines for the implementation of quality management and improvement;
- To build a good relationship in labor development between Mukdahan city and other cities in the CLMVT countries.

Participants

230 participants attended the Seminar. They represented public and private sectors.

Structure and Content

- Presentation on topic "the growth of economy and investment of economy between the country in Mekong region and demand for labor"
- Panel discussion on the topics:
 - Economic growth and investment in the GMS and labour needs.
 - Mechanism of labour skills development for digital technology and AI
 - Upgrading labour skills to international perspective on logistics, production to support SEZs and global economic growth.

Outcomes

Lessons Learnt

- The seminar contributed to solving labor shortage for entrepreneurs and SEZs, and helped to promote cooperation between SEZs in Mukdahan and Savannakhet province on economic connectivity;
- The seminar transferred new knowledge on technology and innovation to the workers.

Suggestion

MI should consider on providing more budget for group AP implementation;

5.3.3. Lao PDR

Introduction



On February 6, 2019, Ministry of Finance, Khammoune Department of Foreign Affairs, Settha SEZ, and Sovan Park SEZ jointly organized a national workshop titled 'Lesson Learnt from Modular Training on Management of Special Economic Zones (SEZs) in Lancang-Mekong Countries'.

Objectives

- To deliver some important lessons learnt from Modular Training on "Management of Special Economic Zones (SEZs) in Lancang-Mekong Countries";
- To disseminate and instruct on real implementation, future directions of SEZ in Lao PDR;
- To discuss, exchange and brainstorm on current and future situations of SEZ implementation in Lao PDR.

Participants

39 participants (22 female and 17 male) attended the event. They represented the Ministry of Planning and Investment, Ministry of Finance, Ministry of Industry and Commerce, Prime Minister Office, Ministry of Energy and Mines, Ministry of Foreign Affairs, Ministry of Labour and Social Welfare, Ministry of National Resource and Environment, Saysettha SEZ, Longthanh SEZ, Dongphosy SEZ, and Nonthong SEZ.



Structure and Contents

- Introduction to important lessons learnt from Training on Management of Special Economic Zones (SEZs) in LM countries;
- Introduction to survey findings and possibility of CBEZ establishment in LM countries;
- Introduction to current implementation and future directions of SEZ and CBEZ establishment in Lao PDR;
- Comments, exchange and sharing

Lessons Learnt

- SEZs will be successful if there is contribution from all stakeholders;
- CBEZs will be implemented/ become successful if there are agreements on policies, legislations and equal benefits between two countries and local stakeholders;
- Participants have learnt and understood more by lessons learnt from real practice on Management of Special Economic Zones (SEZs) in Lancang-Mekong Countries.

Challenges

- Limited budget;
- Lack of necessary updated information: real SEZ or CBEZ practice of successful countries;
- Knowledge and experiences on SEZ and CBEZ of the Laos team are not strong enough.

Recommendations

- Should organize workshops on lessons learnt from Modular Training on Management of Special Economic Zones (SEZs) in LM Countries in the places in which SEZs are located;
- Requested MI to conduct study tour(s) on CBEZ practice in successful countries in order to learn and gain experience;
- Requested MI to assign specialists providing training about SEZ policies of LM Countries in detail to public sector participants from central and local levels.

5.3.4. Vietnam

Group Action Plan Implementation

- Topic: "Chance for joining the global value chain of Vietnamese SEZs".
- Current situation: not implemented.
- Main reason: Could not arrange the budget of around 10,000 USD from the Government.
- Other reason: Depends on the decision of the Ministry of Industry and Trade in which the Team leader is working for.

Individual Action Plan in Saigon Hi-tech Park

- Focus on joining "Global Value Chains", which is understood as "Global Supply Chains" in Vietnam.
- Current situation: Supporting domestic enterprises to join global supply chains of multinational enterprises (ex: Intel, Samsung).
- Target: Supporting Vietnamese SEZs to adjust and meet the common trend of Lancang-Mekong's SEZs for joining global value chains.
- Suggestion: Linking Saigon Hi-tech Park with similar SEZs in Lancang-Mekong to establish a community of science & technology.

Recommendations

- The modular training course should arrange study experiences and visit diversified successful SEZs for participants.
- MI should think about being a hub for linking similar SEZs in LM.

 MI should think about publishing stories of some successful SEZs of each country in LM.

5.4. Information Requirements for SEZs online in Lancang – Mekong Countries

5.4.1. Group Work by Country

In this session, participants were requested to discuss and provide sources for key related information on SEZs in the Lancang-Mekong countries for developing an online SEZ portal, such as relevant legislation, maps, trade and investment data, incentives provision for investors, investment cost, infrastructure, labor resource, public services, one-stop services and other services.



SEZ History in Myanmar

Myanmar has three Special Economic Zones, namely Dawei SEZ, Thilawa SEZ and Kyaukphyu SEZ. Myanmar enforced Dawei Special Economic Zone Law in January 2011 and Myanmar Special Economic Zone Law in 2014, which provided a legal framework for SEZs in Myanmar. Thilawa, Dawei and Kyaukphyu SEZs were approved by the Union Hluttaw (Parliament) under President U Thein Sein government. Management committees were established for Dawei and Thilawa SEZs in September 2013 and for Kyaukphyu SEZ in

January 2014, and new Management Committee members were elected again in October 2016 after the newly democratic government led by a noble laureate resumed power.

The Thilawa Special Economic Zone



- The Thilawa Special Economic Zone located on the outskirts of Yangon is the first SEZ to be built in Myanmar, and became fully (commercially) operational since September 2015. Inside Thilawa SEZ, (where) both (the) hard and soft infrastructure from roads and utilities to supporting services such as maintenance are developed up to international standards. It is located at around 20 km South-East of Yangon, which is the biggest commercial city of Myanmar.
- Thilawa SEZ was established in April 2011 by the first civilian government which was led by the former President U Thein Sein after many decades of socialist government and military rules. After a year of negotiation with Japanese counterparts, the former president U Thein Sein and Japanese Prime Minister Shinzo Abe was able to sign a Memorandum of Understanding for a joint venture for the development of Thilawa Special Economic Zone on April 21, 2012. Thilawa Special

- Economic Zone was intended to be developed into a Public Private Partnership between the two governments and consortiums from Myanmar and Japan.
- In order to promote development of Thilawa SEZ, Myanmar Japan Thilawa Development Limited was formed whereas 10% shares were allotted each to Thilawa SEZ Management Committee on behalf of the Myanmar government and the Japanese government (the Japan International Cooperation Agency); 39% to Japanese consortium of Marubeni, Mitsubishi and Sumitomo, (MMS) and 41% to Myanmar Thilawa SEZ Holdings (MTSH) respectively.

Regulations in economic zones

 - Border gate economic zone (1): Citizens of the opposite border district of the neighbor countries can enter the economic zone with the cross border license. Citizens of neighbor countries and/or third country: exempted from entry visa with stay in no more than 15 days.
- Economic zones (2):
 - Immigration, residence and travel (2)
 - Border gate economic zones (2): Transport vehicles from the neighbor and third countries are allowed in and out with business contract according to the road transport agreement. The drivers are allowed in and out with passport or the People Identification. The goods and vehicle owners of Vietnam are allowed to carry goods and vehicles into neighbor countries for delivery using their passports. Citizens living in border communes of Vietnam are allowed in and out with a passport.
- Economic zones (3):
 - Finance and Credit: Transaction, payment and transfer permitted in Vietnamese currency or the currency of the border country or free currency. Financial institutions are allowed to establish and operate in the zones. Tourists enjoy preferential tariffs when purchasing goods in non-tariff areas in an economic zone.
- Industrial and Manufacturing zones (1)

- Temporary residence regulations: Those who work or/and have work relations are allowed in and out only. Foreigners (directors, managers, experts) are allowed to temporarily reside when
 - Serving production activities
 - Not accompanied by relative and family members
 - Comply with immigration and temporary residence regulations
 - Has accommodation separate from production area.
- Other regulations: Trading activities between manufacturing zones and other areas in Vietnam (excluding non-tariff areas) are import export relations. Those who are working in industrial zones do not declare customs when carrying foreign exchange into economic zones from inside of Vietnam.

5.5. Modular Training Evaluation

<Myanmar>

Relevance

 - 54% of participants met their expectations from the training because of the content of the Modules;

- The participants were highly satisfied with the expertise of resource persons and training methodologies employed during the Workshop;
- Most of the participants are utilizing the lessons learnt from MI training in their own work place with action plans by developing systems and internal knowledge sharing;
- The outcome of the workshop was very successful in viewing to the evaluation made prior to the workshop in comparison with the evaluation made at the end of the session;
- Should have had more examples and country experiences from GMS for more understanding;
- Quality was satisfactory;
- Participants were happy to learn basic knowledge of SEZ and shifting from SEZ to CBEZ which is new to them;
- Framework of CBEZ;
- Institutional & legal framework of SEZ.

Sustainability

- National workshop was successful;
- Need more budget to organize this training and can invite many companies to attend:
- Need MI to be involved in more training and exchange update information of LM countries;
- Financial and technical assistance for sustainability of activities is needed from MI because the participants requested continuation of workshop at least twice a year;
- Workshop participants need regular update on SEZs/CBEZ in the LM countries;
- Need more training and exchange of information among stakeholders of SEZ in Myanmar;
- MI should continue to support for training and help logistic businesses move forward in the I M countries.

Institutional Development & Other Impact

- National Workshop was a brainstorming session;
- On the ground in actual implementation of policy is affected by problems related to implementation;
- Ideas and outcomes of the activity will be published in journals, newspapers and websites;

5.5. Closing Remarks

Dr. Watcharas Leelawath, Executive Director, Mekong Institute

In his closing remarks, Dr. Leelawath expressed satisfaction at the selection of participants for the modular training, remarking that we had a good group of participants. While promoting SEZs in LM countries, the right kind of investments should be targeted, SEZs should not become pollution havens. Dr. Leelawath asked for cooperation of the participants for building a webportal on SEZs by MI. He hoped the participants have built up a good network among them and with MI. CBEZs can help to build value chains. Dr. Leelawath remarked perhaps MI would launch a study to investigate why do investors split production, at which stages production can be split, how do value chains cater to needs of investors etc. He concluded by thanking the participants, the donor and the MI team for organizing a productive S&E workshop and for the successful conclusion of the modular training program.

6. Modular Training Evaluation

The end-of-cycle evaluation was conducted to assess the management and implementation of the modular training program during the period of September 2018 – February 2019, which followed modular training approach with three interrelated stages below:



- Learn to Do: Regional Modular Training on Management of Special Economic Zone in Lancang – Mekong Countries (September 24 - 28, 2018);
- **Do to Learn:** APs implementation (September 2018 February 2019);
- Share to Learn: S&E Workshop (February 12 13, 2019).

The evaluation allowed all participants to freely comment, without the scrutiny of instructors / facilitators and program staff. Different components were rated on a scale of 1 to 5 (1 - Not Satisfied; 2 - Less Satisfied; 3 - Somewhat Satisfied; 4 - Satisfied; 5 - Very Satisfied).

6.1. Workshop Objective

Overall average rating was 4.10. Participants reported that 'to share experience of implementing the APs and obtain feedback from co-participants' to be especially relevant with average rating of 4.46.




Figure 2. Learning Program Objectives

Overall average rating was 3.73. Participants reported that knowledge and skills gained from the training program was relevant to their work / business.




Figure 3. Relevance of Knowledge and Skills

Overall average rating was 3.73. Participants reported that they applied knowledge and skills gained from the training program to their workplace / business.




Figure 4. Application of Knowledge and Skills

Overall average rating was 4.08. Participants reported that they were especially satisfied with the MI's facilitation during the Workshop with the average rating of 4.23.




Figure 5. Program Structure

Participants reported that they were satisfied with the S&E Workshop with the average rating of 4.08.




Figure 6. Overall Assessment

11. Concept Note

11.1. Background

Mekong Institute (MI), with support from the Lancang-Mekong Cooperation Special Fund, successfully conducted one-week Modular Training Program on "Management of Special Economic Zones in Lancang-Mekong Countries" from September 24 - 28, 2018 at its residential training center, Khon Kaen, Thailand. The training aimed to i) improve knowledge base of participants by sharing status on progress on cross border economic zones (CBEZs), ii) build capacities of the special economic zone (SEZ) officials and private sector on various issues related to management of SEZs, iii) share best practices on SEZs / CBEZs and provide examples from Lancang-Mekong countries, and iv) promote learning and exchange among stakeholders. The training program contents included four interrelated modules: 1) Addressing domestic development challenges 2) Leveraging global and cross-border "drivers of change" 3) What makes an SEZ "special" 4) From SEZ to CBEZ and 5) SEZ (and CBEZ) development framework.

As part of the training program, the participants developed the country-wise Action Plans (AP) for transferring their gained knowledge and experiences to related beneficiaries and stakeholders in Lancang-Mekong countries namely China, Cambodia, Lao PDR, Myanmar, Thailand, and Vietnam. The action plans were conducted through national workshops / trainings in their respective countries. It covered dissemination activities for lessons learned on the importance of cross border economic cooperation zones, management of SEZ and CBEZs focusing on global value chain of SEZs, BEZs and CBEZs and new disruptive technology to stakeholders and policy framework for improving SEZs.

To review the learning and the action plan implementation results, and obtain feedback on the modular training cycle, a two-day Synthesis and Evaluation Workshop (S&E) has been scheduled on February 12-13, 2019 at Mekong Institute, Khon Kaen, Thailand. The S&E workshop aims at (i) providing a platform for the participants to present results of their action plan implementation; (ii) sharing best practices and outcomes from their implementation experience; and (iii) reflecting their feedback as contribution to improving the training contents.

11.2. Objectives

The specific objectives of the Synthesis & Evaluation Workshop are to:

- a) Recall the knowledge gained from the modular training program on Management of Special Economic Zones in Lancang-Mekong Countries;
- b) Share experiences of implementing the action plans and obtain feedback from coparticipants;
- c) Provide an opportunity to learn and share best practices and utilize the learning results;
- d) Evaluate the training approach and provide recommendations for future improvement in terms of contents, structure, and schedule.

11.3. Program Activity

The S&E workshop is structured to provide an opportunity for the participants to present their experience of implementing the action plans. The action plan presentation will be in the form of market information, photos, videos, posters display and power point presentations, etc. in line with the topics and methods applied by the action plans. The workshop will also serve as a platform to exchange experience and lessons learned among the participants from their action plan implementation.

11.4. Target Participants

The program is for the participants of the one-week training program held in September 2018 in Khon Kaen from the six Lancang-Mekong countries representing central and provincial ministries and departments of commerce, planning, finance and, agencies responsible for SEZs policies and implementation of SEZs policies and companies involved in SEZs by offering services such as one stop services and acting as SEZ developers.

11.5. Outputs

The workshop is expected to enrich insights of the participants on the impact of the capacity development program from training to the completed action plan implementation. This is also a chance for MI to receive specific recommendations from the participants for further development of MI's training programs.


