Mekong Forum 2024 Exhibitor Terms and Conditions

1. Introduction

Welcome to the Mekong Forum 2024. These terms and conditions govern the agreement between the organizer, Mekong Institute, and the exhibitor ("Exhibitor") for exhibiting at the Mekong Forum 2024 scheduled to take place from July 31, 2024, to August 1, 2024, at Pullman Raja Orchid Khon Kaen, Khon Kaen, Thailand.

2. Application and Acceptance

- 2.1. All applications for exhibit space must be made on the official Exhibitor Application Form provided by the Organizer.
- 2.2. Submission of the application form constitutes a binding agreement between the Exhibitor and the Organizer.
- 2.3. The Organizer reserves the right to accept or reject any application at its sole discretion.

4. Exhibit Space Allocation

- 4.1. Exhibit space will be allocated on a first-come, first-served basis, subject to availability.
- 4.2. The Organizer reserves the right to change the floor plan or relocate an Exhibitor as necessary.

5. Use of Exhibit Space

- 5.1. The Exhibitor shall use the space solely for exhibiting products and services specified in the application.
- 5.2. Subletting or sharing of exhibit space is prohibited without prior written consent from the Organizer.
- 5.3. The Exhibitor shall not display any material that is illegal, dangerous, or offensive.

6. Booth Construction and Display Regulations

- 6.1. Booth setup must be completed by July 31, 09:00 AM
- 6.2. No exhibit may be dismantled before the official closing time of the event.

7. Health and Safety

7.1. The Exhibitor must comply with all health and safety regulations imposed by the Organizer and the venue.

7.2. The Exhibitor is responsible for ensuring that their booth is safe and does not pose any hazards to attendees.

8. Liability

- 8.1. The Organizer is not responsible for any loss or damage to the Exhibitor's property.
- 8.2. The Exhibitor agrees to indemnify and hold harmless the Organizer from any claims arising from the Exhibitor's participation in the Event.

9. Force Majeure

9.1. The Organizer is not liable for any failure to perform its obligations due to events beyond its reasonable control, including natural disasters, war, terrorism, strikes, or government regulations.
